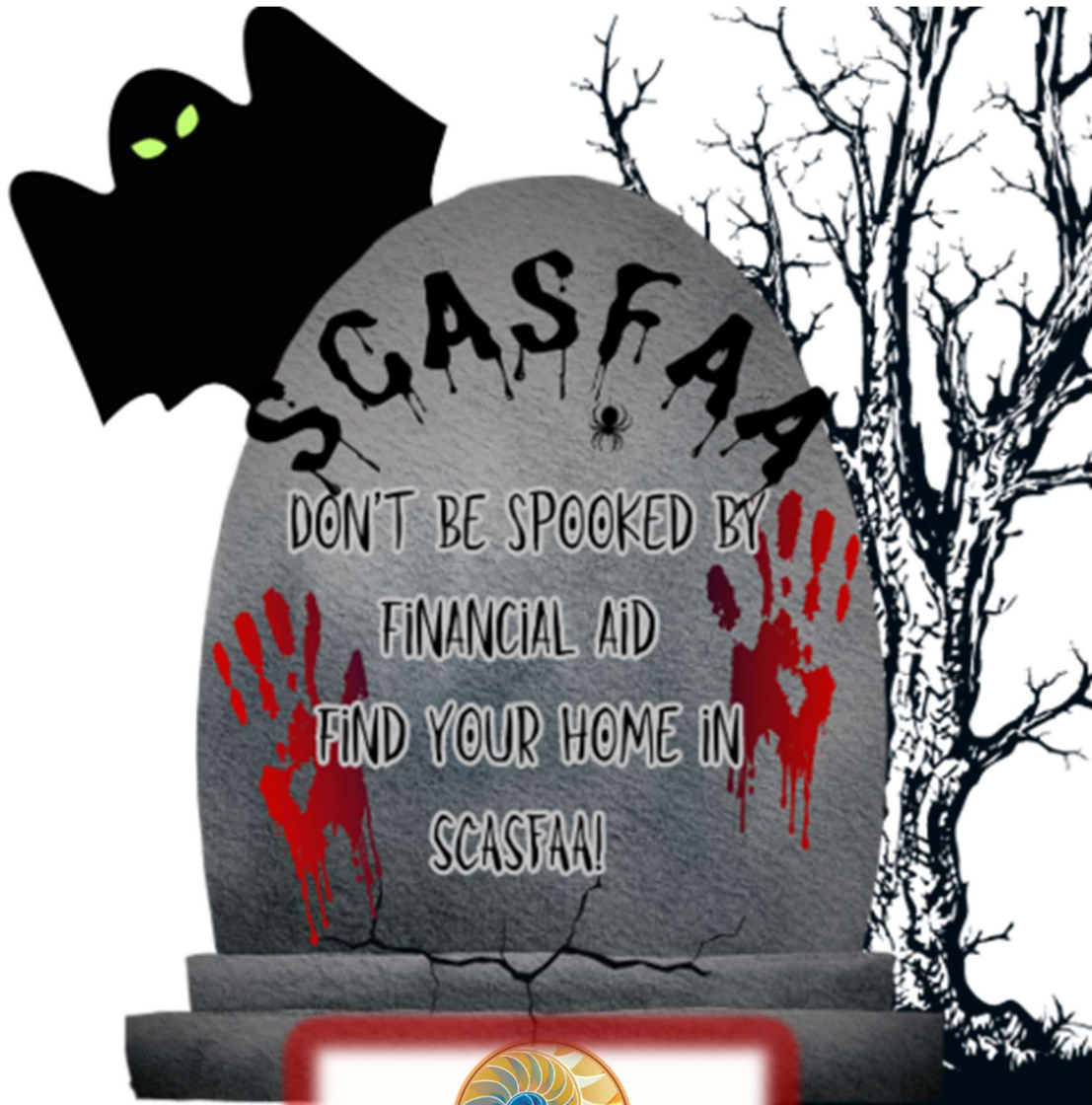

Three remarkable young individuals, who had entered the program alongside their siblings, not only maintained part-time jobs while at Palmetto Place but also pursued various certifications in their chosen fields.

For one youth in particular, Mark, he came to us during this junior year. Not long after, we had two of his siblings in our home. Palmetto Place supported 3 siblings who found themselves unsheltered trying to finish high school. Mark's dedication and hard work paid off when he was awarded scholarships for his exceptional achievements. His scholarships were not just tokens of recognition; it was the keys that unlocked the doors to a four-year college education. We celebrated Mark with each acceptance letter from colleges and each award received from his High School, we wanted to let him know there was still hope in this world, keep pushing, keep going. With a full ride scholarships in hand, he embarked on a new chapter of his life, attending prestigious universities within our state. He maintained a part-time jobs, balanced his studies

with real-world experience. He received certifications, expanding his knowledge and enhancing his resumes. And, most importantly, he never lost sight of our dreams.

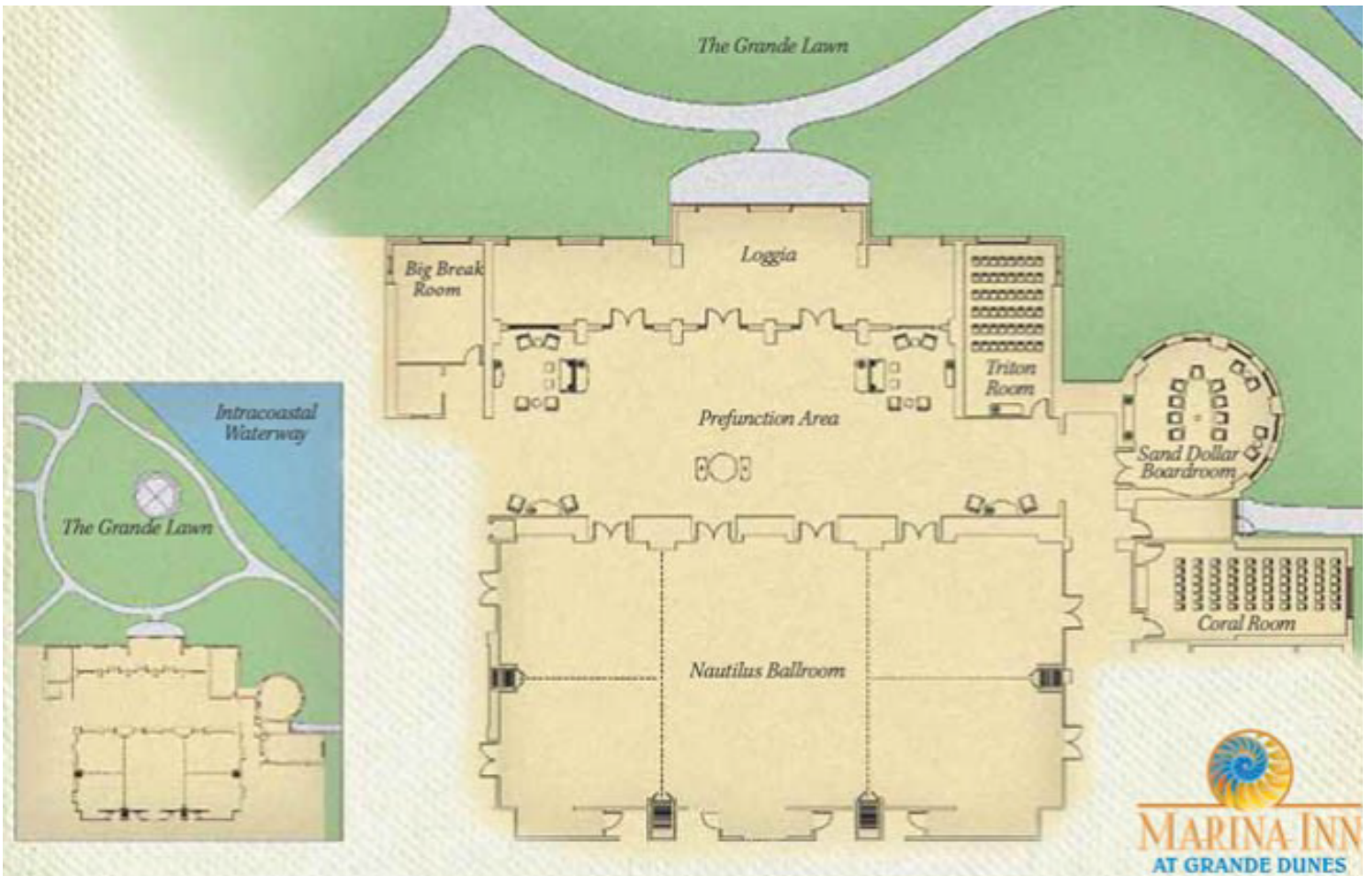
